<p>The Słupsk Special Economic Zone is managed by Pomorska Agencja Rozwoju Regionalnego SA. Located in the northern part of the country, it occupies an area of over 377ha. The Słupsk Special Economic Zone consists of 6 investment areas located in Middle Pomerania (Pomorskie and Zachodniopomorskie Provinces).</p> <p>Entrepreneurs conducting business activities in the Słupsk Special Economic Zone based on a permit obtained take advantage of regional aid in the form of exemption from income tax in connection with new investments or creation of new jobs. The maximum level of regional aid is as follows:</p> <p>40% for large enterprises (employing over 250 people); 50% for medium enterprises (employing less than 250 people), and 60% for small enterprises (employing less than 50 people) and micro-enterprises (employing less than 10 people).</p> <p>In addition, enterprises in the Zone may be exempt from real estate tax (100%).</p>
